On the recommendation of the Vice-Principal (Research and Innovation), Senate endorsed the Strategic Research Plan (SRP) 2019-2024. The SRP expresses McGills core commitments to research, identifies ongoing Research Excellence Themes, and outlines the implementation strategy and objectives over the next five years. The Board of Governors ill receive this item on February 14, 2019.

4. Appointment of Assessor under the Policy on Harassment, Sexual [D18-33] Harassment and Discrimination Prohibited by Law

In accordance it the requirements of the *Policy on Harassment, Sexual Harassment and Discrimination Prohibited by Law*, Senate approved the appointment of Ms. Myriam Larose, immigration advisor in the Faculty of Science and the Faculty of Arts, as an assessor under the Policy, for a three-year term beginning February 1, 2019 and ending January 31, 2022. The mandate of assessors is to investigate a complaint received under the Policy and submit a report of the results of the investigation to the Provost and Vice-Principal (Academic).

5. Report of the Ad Hoc Panel to Conduct a Campus Study of Sexual [D18-34] Violence

The report provided an overviewof the climate on sexual violence at McGill, highlighted emerging or unaddressed gaps in McGill's *Policy against Sexual Violence* and provided recommendations and guidelines to address those concerns.


